On June 30, 1988, the parties agreed to settle all issues, save the issue of the disposition of the parties' assets. The court entered an order memorializing this agreement on July 6, 1988. A final decree of divorce was entered by the trial court on September 13, 1989. On July 5, 1990, the parties submitted a written agreement for approval by the court to settle the issue of the disposition of the parties' marital assets. On August 15, 1990, the court entered an order approving the parties' settlement agreement. The appellant filed an appeal from the order of August 15, 1990, to be served as the final order in the divorce action. The appellant filed her brief on appeal on March 19, 1991. The appellant argues that the trial court erred in denying her appeal from the order of August 15, 1990, when the order did not dispose of all issues, *14 particularly, the issue of the distribution of the parties' marital assets.
