Fidelity & Deposit Co.*, 995 F.2d 1518, 1524 (10th Cir.1993) (recognizing the "better view" that a claim against a surety is separate and distinct from the claim against the principal); *Chateaugay Corp. v. Fidelity and Deposit Co. of Maryland*, 922 F.2d \*1351 338, 341 n. 3 (2d Cir.1990) (stating that "suits against a surety on a bond are in no way precluded" from being brought separately against the principal and the surety); *Fidelity and Deposit Co. of Maryland v. Bourland*, 453 F.Supp. 1072, 1074 (E.D.Tex.1978) ("[I]t has long been the settled law in this circuit... that, absent an express agreement otherwise, suit on a bond against a surety is a valid independent claim.")
